


Overall, I consider security a necessary service.




I consider the security costs reasonable.





I think 70 hours per week of security services is sufficient.




I would be willing to pay more in annual dues for more than 70 security hours.






I think house checks for vacations and long absences are a necessary and I'm willing to trade patrol time for my home checks.






I think notifying me that my garage door is open is a necessary service and I'm willing to trade patrol time for my garage door notifications.






I think replacing radar speed sign batteries is a necessary contracted service. I'm willing to pay for it.






I am satisfied with the timeliness of the response of Community Safety Patrol.








